Celebrating 70 years of Salt River News

Like many of you, I look forward to receiving my Kentucky Living magazine in the mail each month. We've surveyed members through the years, and the statewide publication, which boasts a circulation of more than 477,000 readers a month, is always a hit!

And like many of you, the first thing I do when I get my magazine is flip to the center and read Salt River News, our locally-produced newsletter for the members of Salt River Electric. It's always a good place to find the latest news from the cooperative, in addition to safety articles, energy efficiency tips and stories from our communities.

As you might have already noticed, the layout and design of Salt River News is different this month than when you last picked it up back in May. That's because July marks 70 years of our locally-produced, member-focused newsletter-and what better way to celebrate the occasion than with a fresh new look for our members?

For those who don't remember or weren't around (including myself), Salt River News was first published in July 1953 by then-Salt River RECC Manager J.S. Broaddus and clerk Charleen J. Conley. Then known as Co-Amp News,



the publication was created to keep members of the stillyoung business up to date on the latest cooperative news and community information. At a price of 25 cents per year, members were also treated to tips on how to electrify their homes, from the barnyard to the kitchen. Going through our archive of newsletters, you can see monthly columns congratulating a member on their new "electric homes."

70 years later, publications like Salt River News are still important to our members. In many ways, today's

newsletter remains unchanged.

Sure, it now has a fresh, clean and updated look, but its objective remains the same as when Mr. Broaddus offered this quote seven decades ago:

Maddox to represent Salt River on EKPC Board of Directors

Salt River Electric has a new face representing the cooperative at East Kentucky Power Cooperative.

During the power provider's annual meeting on June 13, East Kentucky's 16 owner-member cooperatives gathered at the company's Winchester headquarters to, among other things, nominate and appoint new leadership to the EKPC board of directors. It was announced that George Maddox will now represent Salt River Electric at East Kentucky's board meetings.

"I'm more than happy to represent our co-op at East Kentucky, and that our local board trusts me to do so," Maddox says. "I'm looking forward to getting to know more about the generation and transmission side of the business, in addition to representing our co-op's needs."

The nomination and appointment



of Maddox comes just a year after Salt River's longtime EKPC representative Jimmy Longmire stepped down due to his resignation from the Salt River board. Darrell Tingle, director for Washington County, had filled in on the East Kentucky board following Longmire's departure.

Salt River representation at EKPC

Since joining in March 1949, Salt River Electric has seen seven individuals represent the board of East Kentucky Power Cooperative. Bullitt County director George Maddox became the eighth person after being nominated and confirmed this past month.

Salt River Electric celebrates members and annual meeting

Enjoying clear skies and moderate temperatures, Salt River Electric staff once again manned the drive-thrus at all four offices to show their appreciation during the cooperative's annual Member Appreciation Day.

Last year, participation for the event was high, with the cooperative seeing the largest number of participants for an appreciation day/annual meeting in the last 30 years. Participation exceeded expectations again this year, as more than 3,200 members registered for gift card giveaways and picked up their treasured bucket and bulbs.

"This really is one of the best times of the year at Salt River," President/CEO Tim Sharp says. "We wouldn't be here without our members, so it's an opportunity to show our members that we appreciate their support of the cooperative idea."

In addition to the buckets and bulbs, members received a custom Salt River Electric yardstick, as well as a bank draft sign up form and recipe postcards from *Kentucky Living* magazine.

Election results announced during annual meeting

That evening, Salt River's board of directors gathered for the co-op's 85th annual meeting. The event, which took place at the cooperative's main office and streamed live on various online platforms, announced the results of the 2023 Nelson County board election. Elaine Hammond, speaking on behalf of the member-populated election commission, announced that Linda West and John Hutchins had been re-elected by the district's membership to the board. The two were re-elected to four-year terms.

Following the annual meeting, the board met in an organizational meeting to determine leadership roles. West was once again named board chair, with David Stevens (Spencer County) serving as vice chair, Darrell Tingle (Washington County) serving as treasurer, and George Maddox (Bullitt County) serving as secretary.

Co-op presented with safety award

Before the annual meeting began, Salt River Electric was presented with a safety award from Kentucky Electric Cooperatives, congratulating the co-op on 235,686.30 hours of work without lost time due to an accident or injury. The award was presented by Randy Meredith, the statewide association's director of safety and training.



Safety Matters

Firework safety tips

Whether you're in charge of a fireworks display for your community or you're just having fun with your kids and some sparklers, put safety above all else this Fourth of July.

Steer clear of power lines: A fireworks display, no matter how grand or how modest, should take place only in open areas where there are no power lines at all. Fireworks that contact power lines can start a fire, injure spectators and leave nearby homes without electricity.

Have water nearby: No matter if it's a bucket of water or a simple garden hose, make sure you have quick access to water in the event that you need to put out a firework.

Keep an eye on sparklers: You might think of them as kid-friendly, but sparklers can cause serious injury, burning at around 2,000 degrees Fahrenheit. If you decide to give them to kids, make sure to properly supervise them.

One at a time: You certainly want your fireworks to be the talk of the neighborhood, but unless you're a pyro professional, make sure to light one firework at a time to decrease the risk of an accident.
