

## 2024 Scholarship Application

### Salt River Electric Scholarship Program

This year, Salt River Electric has several scholarship opportunities:

- Eight (8) \$1,000 scholarships (awarded two per board district)
  - In each district, one scholarship will be awarded to a graduating student pursuing a traditional degree at a college or university, and one will be awarded to a graduating student pursuing a career through a trade or vocational program at an accredited school.
- One (1) Larry Hicks Memorial Scholarship in the amount of \$2,000 (criteria below).

#### Program Requirements:

1. Any applicant interested in one of the eight Salt River Electric scholarships must be high school senior who is on track to graduate at the end of the 2023-2024 school year.
2. Applicant must be enrolled or have plans to enroll at an accredited college, university, vocational or trade school.
3. All applicants must reside on Salt River Electric lines, or the primary residence of their parents or guardian must be located on Salt River Electric lines.
4. Applicants for the Larry Hicks Memorial Scholarship must be enrolled full-time at an accredited college or university, and have completed **at least** 60 credit hours towards a degree in finance or accounting.
5. Applicants for the Larry Hicks Memorial Scholarship must complete the attached form, as well as a typed essay on the provided topic. Essay will become property of Salt River Electric.

#### Required Documents for all scholarships:

1. Completed Scholarship Information Form
2. A copy of applicant's most recent transcript (unofficial)

**In addition to the above requirements, applicants for the Larry Hicks Memorial Scholarship must submit:**

3. A typed essay on the provided topic
- Completed applications can be turned in to any of our four Salt River Electric offices, to the attention of **Diana Edwards**.
  - Recipients will be contacted prior to the cooperative's annual meeting to gather additional information, and will schedule a time to have their photograph taken, to be used by the cooperative in marketing and promoting the scholarship program.
  - Scholarship recipients will be announced during the cooperative's annual business meeting on June 3<sup>rd</sup>.
    - Funds are not renewable, and will be paid to the recipient's school following their announcement.
